# Fire Risk Assessment Duties and Duty Holders

Under **current fire safety legislation**, all persons in control of premises known as **Duty Holders are required to carry out fire risk assessments**. This means identifying potential fire risks and taking appropriate measures to safeguard anyone who may be affected.

This legal duty applies to employers (for workplaces) and landlords (for non-domestic premises and shared areas of domestic buildings), and is in addition to the employer's responsibility to protect their staff.



# Tower Blocks

In July 2009 a serious fire in a tower block known as Lakanal House in London resulted in 6 people dying. The Coroner's Court expressed concern over the actions of the Landlord in this case, in particular over the lack of control over building works in ensuring compliance with fire safety.

One criticism was the removal of asbestos materials and replacement with inferior products. In response, ACS established a partnership with a national commercial building surveying firm to enable the integration of structural appraisal into the Fire Risk Assessment of tower blocks, ensuring the important aspects of structural integrity are properly analysed.

***"It is a strong recommendation that those organisations responsible for the management of high-rise blocks, carry out an assessment of fire risk in the building, as part of their corporate responsibility." while recognising that "A fire safety risk assessment is not, however, legally required under Part 3 of the Fire (Scotland) Act 2005, for the common areas of domestic premises."***

# Learning from Grenfell: Why Fire Safety Can't Be an Afterthought

The 2017 Grenfell Tower tragedy claimed 72 lives. The final report, published in September 2024, identified critical failures in fire safety planning, risk assessment, resident protection, and regulatory enforcement. It confirmed what many in the industry feared: decades of systemic neglect, poor communication, and unqualified decision-making led to one of the UK's worst housing disasters.
